In September 2017 Valerie transitioned to her current role of Assistant Vice President for Community Impact Operations. In this new role Valerie helps oversee the day-to-day operations of the Community Impact Department and works to ensure that strategies, investments, and policies align to ensure maximum success of department activities.

Valerie graduated from Miami University with a degree in Communications. Franklin County Children Services, Mission: Through collaboration with families and their communities, we advocate for the safety, permanency and well-being of each child we serve in a manner that honors family and culture.

We are committed to our Guiding Principles:

- We are child welfare professionals
- We honor families
- We value every child
- We value partnerships

Children Services is the public agency mandated by federal and state law to ensure that our community's children are safe and well cared for. We provide protection, care and permanency for children who are abused, neglected or dependent. By being in partnership with more than 100 agencies and organizations, and with the help of over 700 employees, 500 kinship families, 200 adoptive families, 500 volunteers and mentors and hundreds of community foster parents, the agency is committed to making sure that every child has a safe and stable home. Children Services social workers and support staff work to build stable and

supportive living settings for young people, strengthen family life and assist parents in meeting their responsibilities to their children. FCCS receives approximately 30,000 referrals annually through our 24-Hour Child Abuse Hotline — (614) 229-7000.

Representative *Alison Rodger* has worked with FCCS for 25 years. Having started as an intern, then working as a caseworker, casework supervisor, trainer and most recently as the director of professional development and the Central Ohio Regional Training Center, helping coordinate training for 12 central Ohio counties.

Her background in casework, supervision, adoption, substitute care, training and staff development embodies the Guiding Principles of We are Child Welfare Professionals and We Value Partnerships. Her work has assisted staff in developing their skills to become stronger advocates in serving the children and families of Franklin County.

In October 2019 Alison was promoted to Director of Communications and began a new leadership journey. She currently oversees Franklin County Children Services Professional Development Department, and Community Outreach Department, and the Volunteers Department. She is a partner and a liaison for several groups in her new role, including the Franklin County Youth Council.

She holds an undergraduate degree in psychology and sociology from Hampton University and a Master of Social Work degree from the Ohio State University.

Franklin County Department of Job and Family Services (Franklin County Board of Commissioners Agency), Mission: The Franklin County Department of Job and Family Services provides workforce development and family support programs that improve the quality of life for Franklin County residents.

We provide the following services:

- Food Assistance
- Emergency Assistance
- Child Care Program
- Medical Assistance / Medicaid / Healthy Start
- Ohio Works First
- OhioMeansJobs Center

The Franklin Department of Job and Family Services (FCDJFS) is a county, state and federally supported agency responsible for basic financial, medical and social services programs. These programs are made available to ensure that no one is forced to go without the basic essentials of food, clothing, shelter, medical care and necessary life sustaining services because of a lack of resources. FCDJFS ensures that many eligible children and adults receive assistance each month through in-house or contracted services.



Franklin County also provides education and training for public assistance customers along with the necessary support services to help them find quality jobs and move from welfare to independence. This opens doors to employment by improving participants' job seeking skills, building self-confidence and providing on-the-job training. The goal of our agency is to place job-ready participants in unsubsidized employment in the shortest possible time. Emphasis is placed on job placement activities, remedial education and vocational training. These activities are coordinated with other available employment and training programs within the community.

Representative Joy Bivens is Director of the Franklin County Department of Job and Family Services (FCDJFS), the largest agency under the Board of Commissioners, with a budget of more than \$72 million and approximately 630 employees. The Department serves over 350,000 individuals receiving public assistance and Medicaid: and contracts for approximately \$16.2 million in early childhood, youth, adult and senior and disabled services. Prior to being named the Director, she held the position of Chief Operating Officer (COO) with the agency. Before joining FCDJFS, Bivens was co-owner of a home care agency from 2006-2015. During that time her company provided home care services to nearly three thousand (3000) patients throughout the State of Ohio. Bivens has served on the Whitehall School Board for the past 2 years and is the past Vice President of the Whitehall Area Chamber of Commerce. Bivens is the past board chair of The Ohio Means Jobs-Franklin County/COWIC.

Bivens obtained a Bachelor's Degree from Capital University and in February 2015, she received the African American of Excellence Award from Central Ohio Youth Advocacy Program. In addition, she was named the 2015 Whitehall Citizen of the Year and was recognized by Governor John Kasich as a Business Leader.

Bivens has been married to her husband Attorney Michael Bivens for eighteen (18) years. They have two (2) children, a daughter Mikayla and son Michael. Both Bivens and her husband believe in giving back to the community; evidenced by not only committing their time but also opening their home to young adults who are in transition.

Representative Tori Darden is the Social Program Developer of the Franklin County Department of Job and Family Services (FCDJFS), the largest agency under the Board of Commissioners, with a budget of more than \$72 million. As the Social Program Director Tori is responsible for the following:

- Develop/implement plans and projects to increase community organization linkages
- Monitor contract compliance, services, and program outcomes.
- Collaborate with community groups to identify and recommend new contracted services to support agency objectives.
- Provide technical assistance, consultation, and inform community groups of programs, policies and procedures governing service provision.
- Serve on informational and/or advisory groups and organizations.

Rise Sister Rise, Fran Frazier

Rise Sister Rise: Evaluating the African American Girls' Experience of Trauma and Resilience in Ohio's Communities is a journey towards academic success and positive socialization for African American girls. There are approximately 201,000 African American girls living in Ohio; the majority residing in metropolitan areas. Research suggests that urban African American girls are significantly exposed to more traumatic stressors than children of other racial groups. The Rise Sister Rise Research Project is designed to explore the ways in which urban adolescent African American girls experience their world and the ways in which they are affected by those experiences. Frances Curtis Frazier, M.A. is the principal investigator and research partner with the Ohio Department of Mental Health which provided original funding for the research project.

Representative Frances Curtis Frazier is the Principal Investigator of "Rise Sister Rise: Placing Black Girls at Promise" a participatory action research study on the lives of 409 African American girls in four Ohio cities. The ground-breaking research identified specific determinants of health affected by traumatic stressors in addition to the journey towards resiliency experienced by these girls. The gift of this research is that currently community leaders, educators, mental health practitioners, gateway providers in all four cities in addition to state, county and local government are actively involved in using the data towards more culturally competent services, policies and programs for girls and their families.

Fran is also a Senior Associate with the Paul J. Aicher Foundation/Everyday Democracy and works nationally on issues of structural racism and racial equity. Fran Frazier holds a MA in Learning Disabilities and Behavioral Disorders from The Ohio State University and a B.S. cum laude in Special Education from Norfolk State University. She is the recipient of many local, state and national awards and recognitions, especially the Sharon Burks Soar Award from Franklin County Children Services and the History Makers, a national organization that recognizes lifetime achievements of African Americans.
